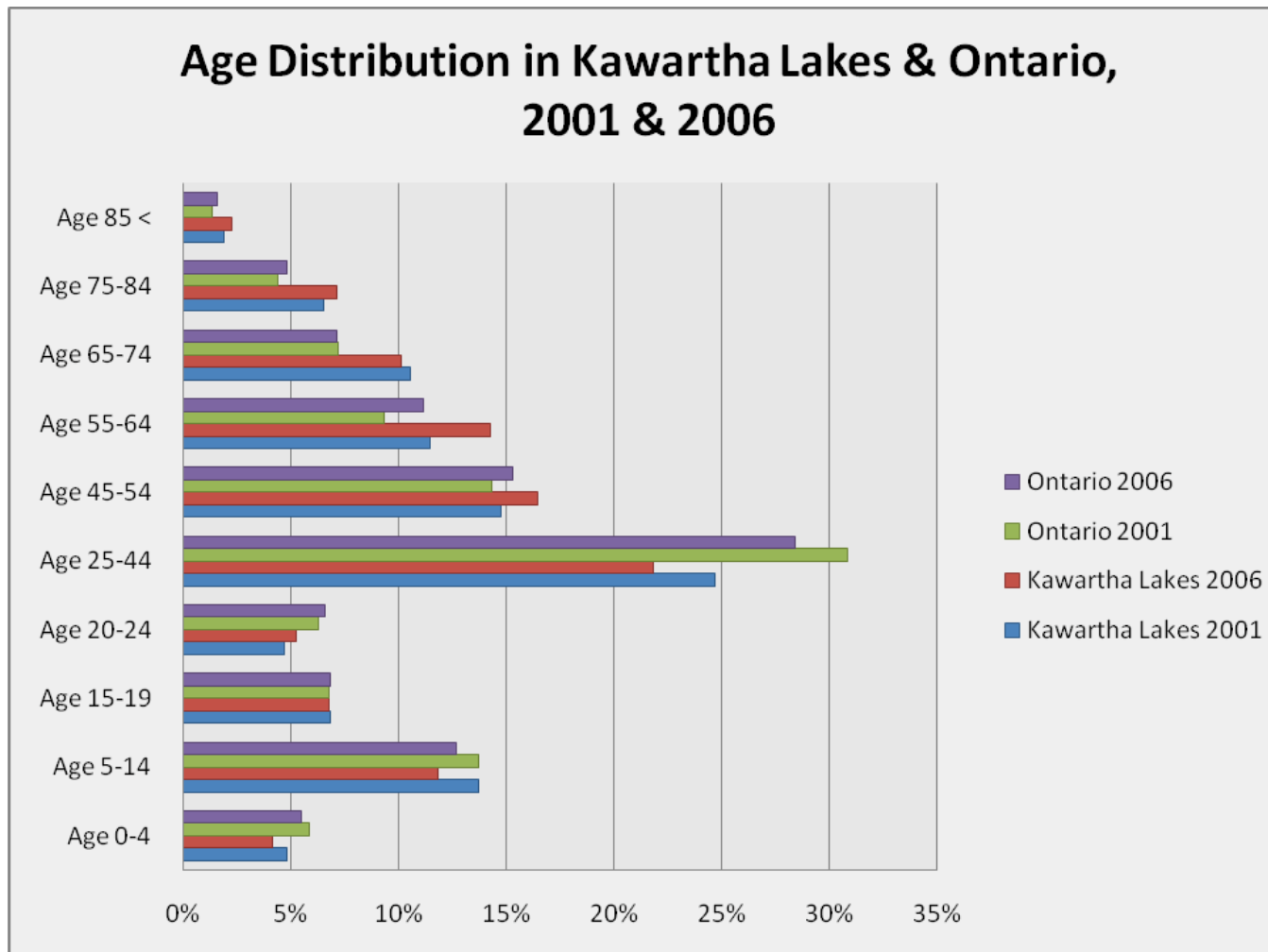

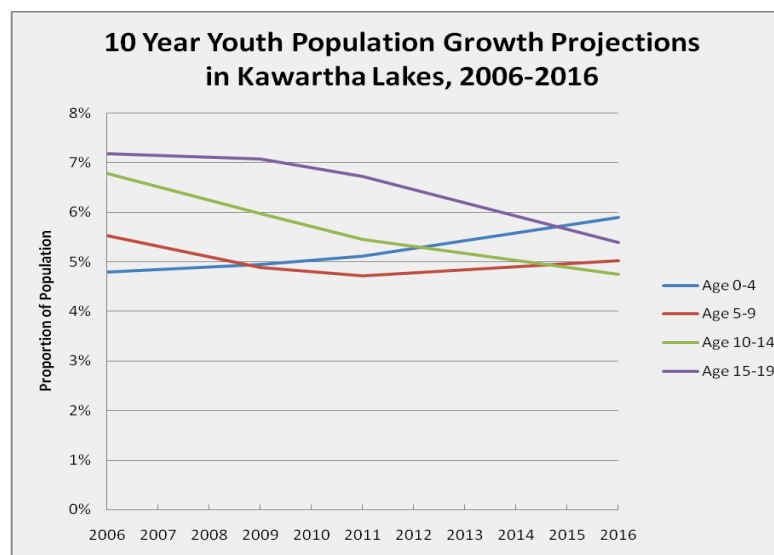

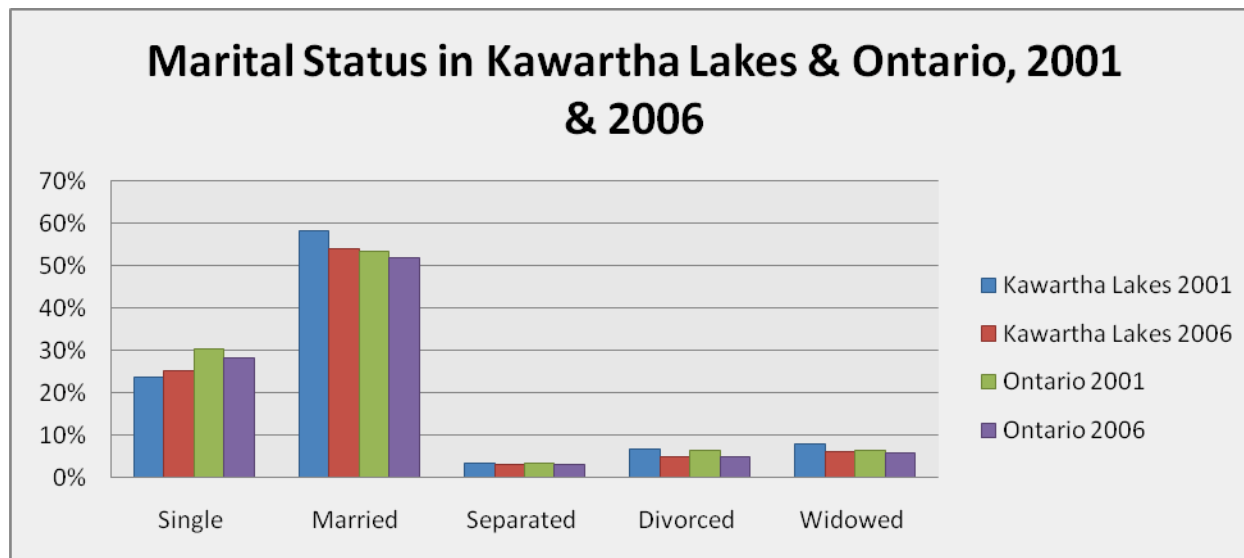

Comparisons of Townships within City of Kawartha Lakes

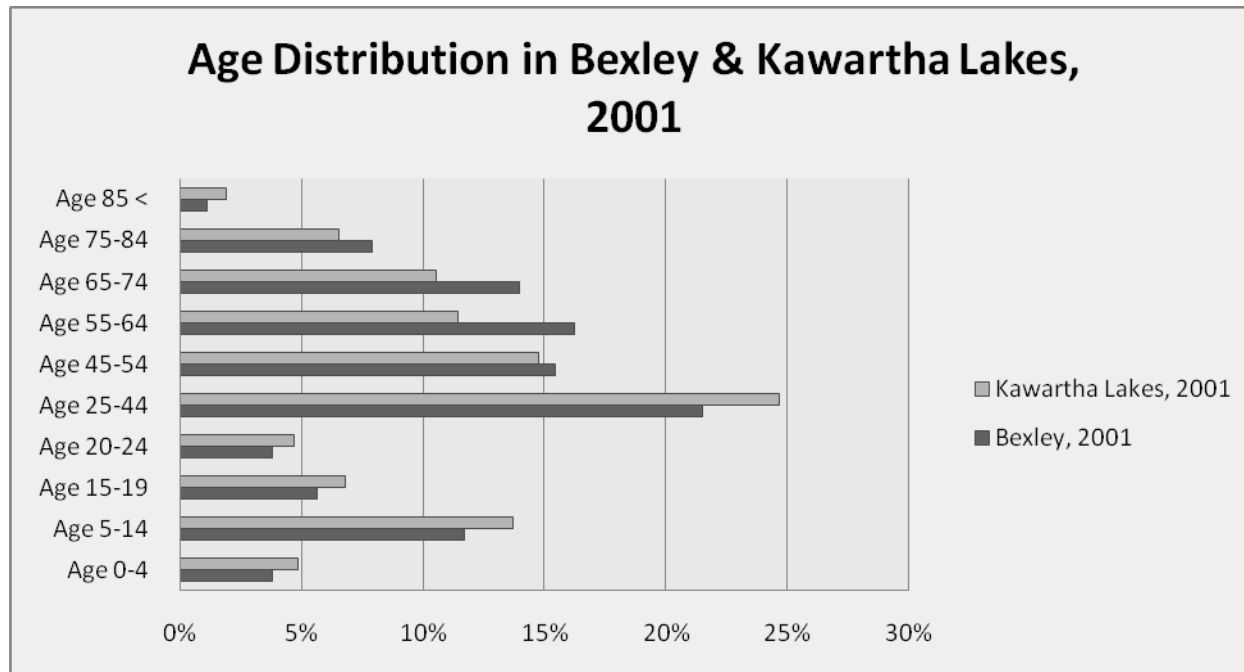

The following observations were taken from the 2007-08 Best Start Community Vision Phase Two: Building Up From the Foundation (June 2007).

- There are 24 schools with kindergartens spread across the City of Kawartha Lakes

- There is a high concentration of 0-6 year olds in the Omemee postal code area, but families in this border area tend to travel to Peterborough for services. The Health Unit's Healthy Babies Healthy Children programme reports a jump in the number of births in the past year.
- Bobcaygeon has a significant number of seniors (44% of residents were over 65 in the 2001) yet the number of early years families is stable and the OEYC Rural Mobile site there is well attended.
- Coboconk, Norland and Kinmount have low family income levels for families with at least one child 0-6 years old, and issues exist regarding food security and transportation.
- There is a new school in Coboconk with space to build a community hub.
- Lindsay is the only 'urban' centre in the City of Kawartha Lakes and Haliburton. It has the highest concentration by far of early years children (1,290 children 0-6).
- The town is seen to be significantly underserved for parenting programmes and child care compared to the population.
- There are 11 schools with kindergartens within 15 km.
- The school boards indicate that there is no space availability in the 11 Lindsay schools to integrate child care centres, so an alternate solution may need to be sought that recognizes the important linkage premise of Schools First.
- There are 2 child care centre, 2 half day programmes and 1 nursery programme.

Early Development Instrument Results

The Best Start Network completed its report “Best Start Community Vision: Phase Two” (June, 2007). In the report it identifies the Early Development Instrument (EDI) results. The EDI instrument was developed by the Offord Centre at McMaster University to measure children's readiness to learn at school – the child's ability to meet the task demands of school, such as being cooperative and sitting quietly and listening to the teacher and to benefit from the school's educational activities.

The EDI measures how ready children are to begin learning at school by asking questions about five different areas of their early development:

- Physical health and well-being
- Social competence
- Emotional maturity
- Language and cognitive development
- Communication skills and general knowledge.

The EDI is completed by teachers for all children in kindergarten classes. In the 2005/6 it was completed for over 90,000 children in various sites across Canada, including every senior kindergarten in the CMSM. Funding of the EDI for over 700 students was provided by the local Ontario Early Years Centre with the main office in Lindsay through project funding from the Ministry of Children & Youth Services. Further analysis of EDI raw scores is completed by the Data Analysis Co-ordinator at the OEYC.

The EDI measures the outcomes of children's early years as they influence their readiness to learn at school. In other words, EDI results provide insight into how well we, as a community support our families and children in the pre-school years, before they step through the doors of school at four years old. The EDI does not provide diagnostic information on individual children, neither is it designed to measure the school's performance.

Local EDI results indicate:

- 5 year olds in the City and County scored slightly higher on average than the normative sample on all five domains.
- Despite this, we do have vulnerable children in neighbourhoods across our jurisdiction. We did have a higher than average percentage of children who scored in the lowest 25% on at least one domain (26.6% with 25.9% being the norm) as well as those who scored in the lowest 25% on at least two domains (15.1% with 12.9% being the norm), though this was not a statistically significant difference.
- Children who attended French Immersion did not do significantly better in any of the domains.
- Girls scored significantly higher than boys on all five domains.
- At this time, 5 year olds living in the postal code in the west end of Haliburton County scored lower on average, than the central postal code neighbourhood. Results were not released for the eastern postal code neighbourhood because a number of students was too low.
- At this time, 5 year olds living in the postal code areas in the south end of the City of Kawartha Lakes scored lower than those living in the north end of CKL.

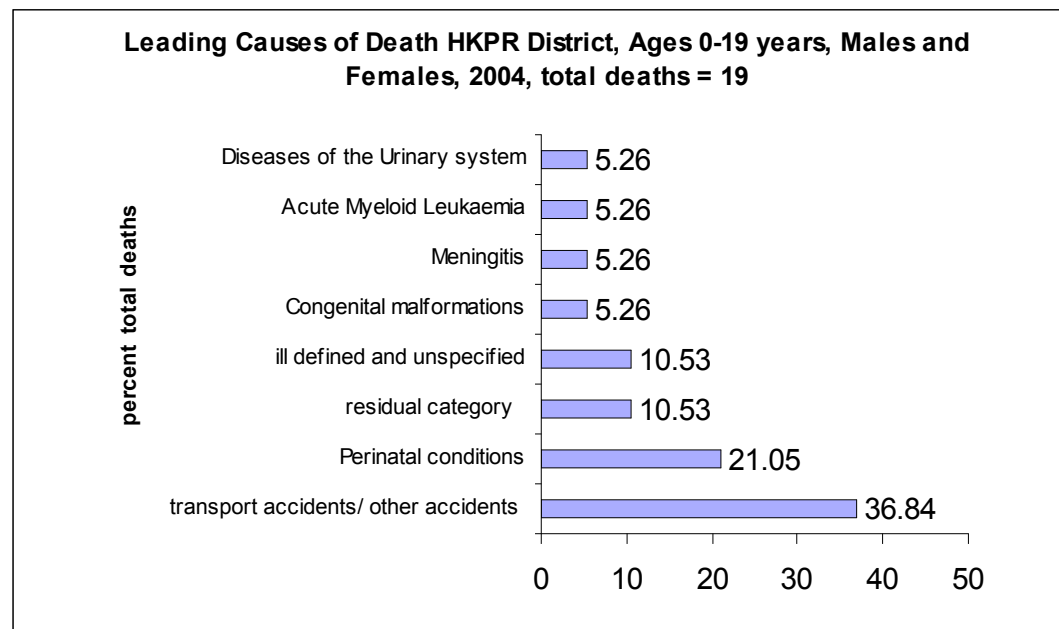
